<p>RESEARCH, INVESTIGATIONS &amp; RESCUE - PETA receives complaints of cruelty to animals, works for the release of and obtains care for abused, neglected, and at-risk animals, investigates cruelty cases, gathers evidence of law violations, and takes action to ensure the enforcement of laws and regulations in an effort to protect the animals involved. We publicized the results of our undercover investigation into a PetSmart supplier in Texas, where we documented the neglect and agonizing death of a baby cockatoo. We also released undercover video footage taken inside two Tyson slaughterhouses, where workers were documented throwing live birds, tearing off birds' heads, and urinating on the conveyor belt that takes birds to slaughter. We aided in the successful prosecution and conviction of many animal abusers, including a North Carolina man who let his pit bull starve to death, horse abusers in California, a worker who was caught abusing pigs during PETA's undercover investigation of Murphy Family Ventures, a North Carolina sow farm, and a man who posted video of himself throwing rabbits and dogs 30 feet in the air. Note 1 Fixed assets are recorded at their cost and are depreciated using the straight line method, half year convention, over their useful lives. Furniture, Equipment and Vehicles are estimated to have useful lives ranging from 3 to 10 years. Buildings and improvements have useful lives ranging from 5 to 50 years. Improvements are amortized over the lesser of the remaining life of the lease or the estimated useful life of the improvements. Upon retirement or disposal of assets, the cost and accumulated depreciation and amortization are eliminated from the accounts and the resulting gain or loss is included in the Statement of Activities.
