8 IT IS HEREBY ORDERED, ADJUDGED AND DECREED in  
9 accordance with said Stipulation that The People of the State of  
10 California have judgment against defendant Sunrider as follows:

12 JURISDICTION

13 1. This action is brought under California law and  
14 this Court has jurisdiction of the subject matter hereof and  
15 the parties hereto.

16  
17 DISCLAIMER OF ADMISSIONS

18 2. The provisions of this Judgment are entered as  
19 a result of the stipulation of the parties, without admission  
20 by any party regarding any issue of fact or law alleged in  
21 the complaint.

22  
23 APPLICABILITY

24 3. The provisions of this Judgment, including the  
25 injunction contained herein, are applicable to the defendant  
26 corporation and to its officers, and to all persons acting in

1 concert or participation with the defendant who have actual or  
2 constructive knowledge of this Judgment.

3  
4 INJUNCTION

5 4. Defendant Sunrider Corporation, dba Sunrider  
6 International, and all persons and entities set forth in  
7 Paragraph 3 above, are hereby permanently enjoined and restrained  
8 from:

9 a. Making, or causing to be made, representations  
10 on food packages or other containers which are untrue or misleading  
11 in that they fail to accurately represent the contents and  
12 ingredients of the products contained in such packages within  
13 the meaning of Health and Safety Code Sections 26002 and 26550.

14 b. Offering for sale, selling, or advertising  
15 misbranded food within the meaning of Health and Safety Code  
16 Sections 26002 and 26550.

17 c. Representing that its products have any effect  
18 on disease or medical conditions within the meaning of Health  
19 and Safety Code Section 26463.

20 d. Intentionally selling, delivering, or attempting  
21 to sell or deliver "new drugs", as that term is defined in  
22 Health and Safety Code Sections 26010 and 26021, without  
23 satisfying the requirements of Health and Safety Code Section  
24 26670.
