**VOLUNTARY SURRENDER ORDER**

On the 4th day of November, 2011, came on to be heard before the Texas Medical Board (the "Board"), duly in session, the matter of Andrew William Campbell, M.D. ("Respondent").

With the consent of Respondent, the Board makes the following Findings and Conclusions of Law and enters this Voluntary Surrender Order.

**FINDINGS**

The Board finds that:

1. Respondent received all notice required by law. All jurisdictional requirements have been satisfied. Respondent waives any defect in notice and any further right to notice or hearing under the Medical Practice Act, Title 3, Subtitle B, Texas Occupation Code (the "Act") or the Rules of the Board.
2. Respondent currently holds Texas Medical License No. G-7790. Respondent was originally issued this license to practice medicine in Texas on June 9, 1985.
3. Respondent is board certified in family practice.
4. Respondent is 63 years of age.

5. On June 28, 2011, the Board entered a Final Order ("Order") in SOAH Docket 503-04-5717. Due to financial and health reasons, Dr. Campbell asserts that he will be unable to comply with certain provisions of the Order.

6. By reason of the above, Dr. Campbell has requested voluntarily surrender of his license to practice medicine in Texas.

7. Respondent has cooperated in the investigation of the allegations related to this Voluntary Surrender Order. Respondent's cooperation, through consent to this Voluntary Surrender Order, pursuant to the provisions of Section 164.002 of the Act, will save money and resources for the State of Texas. To avoid further investigation, hearings, and the expenses and inconvenience of litigation, Respondent agrees to the entry of this Voluntary Surrender Order and to comply with its terms and conditions.

### **CONCLUSIONS OF LAW**

Based on the above Findings of Fact, the Board concludes that:

1. The Board has jurisdiction over the subject matter and Respondent pursuant to the Act.

2. Section 164.061 of the Act and 22 TEX. ADMIN. CODE 196.1 authorizes the Board to accept the voluntary surrender of Respondent's Texas medicine license.

3. Sections 164.051(a)(4) of the Act authorize the Board to take disciplinary action against Respondent based on Respondent's physical condition.

3. Section 164.001 of the Act authorizes the Board to impose a range of disciplinary actions against a person for violation of the Act or a Board rule.

4. Section 164.002(a) of the Act authorizes the Board to resolve and make a disposition of this matter through an Agreed Order.

## ORDER

Based on the above Findings of Fact and Conclusions of Law, Board ORDERS that:

1. The voluntary surrender of Respondent's Texas license should be, and is, accepted by the Board effective on the date this Voluntary Surrender Order is signed by the President of the Board.
2. Respondent's Texas Medicine License G-7790 is, therefore, surrendered.
3. Respondent shall immediately cease practice in Texas. Respondent's practice after the date of entry of this Voluntary Surrender Order shall constitute a violation of this Voluntary Surrender Order, subjecting Respondent to disciplinary action by the Board or prosecution for practicing without a license in Texas.
4. Respondent shall not apply for re-licensure before the first anniversary of the date on which this Voluntary Surrender Order became effective.
5. Respondent may apply for re-licensure only once per year thereafter.
6. In addition to establishing compliance with current licensure eligibility requirement under Texas Occupation Code, Title 3, Subtitle B, Sections 164.051, 164.061, and Chapter 155, Respondent's application for re-licensure shall demonstrate he is in full compliance with all Board Rules governing the reissuance of a medical license contained within Texas Administrative Code, Title 22, Part 9, Chapters 163; 167, including but not limited to 167.1(b), 167.3, 167.4, 167.5, and 167.8; and 196.
7. By this voluntary surrender of Respondent's Texas medical license, Respondent resolves any complaints currently before the Board.
8. This Order supercedes any and all previous Orders of the Board.

RESPONDENT WAIVES ANY FURTHER HEARINGS OR APPEALS TO THE BOARD OR TO ANY COURT IN REGARD TO ALL TERMS AND CONDITIONS OF THIS AGREED ORDER. RESPONDENT AGREES THAT THIS IS A FINAL ORDER.

THIS ORDER IS A PUBLIC RECORD.

I, ANDREW WILLIAM CAMPBELL, M.D., HAVE READ AND UNDERSTAND THE FOREGOING VOLUNTARY SURRENDER ORDER. I UNDERSTAND THAT BY SIGNING, I WAIVE CERTAIN RIGHTS. I SIGN IT VOLUNTARILY. I UNDERSTAND THIS AGREED VOLUNTARY SURRENDER ORDER CONTAINS THE ENTIRE AGREEMENT AND THERE IS NO OTHER AGREEMENT OF ANY KIND, VERBAL, WRITTEN OR OTHERWISE.


