A citation is hereby issued to you in accordance with Business and Professions Code Section 651 (k) for violation of Section 651 of the Business and Professions Code and an administrative citation is hereby issued to you in accordance with Business and Professions Code section 125.9 for violation of section 2285 of the Business and Professions Code and section 17500 of the Business and Professions Code.

**License**

License A 22848 was issued to you on 25 June 1968 and expires 31 March 2010.

**Cause for Citation**

From 2007, you have provided false and misleading advertisements in violation of section 17500 of the Business and Professions Code, you have disseminated false and misleading advertisements through various Internet websites in violation of Section 651 of the Business and Professions code and you have practiced under the name "Medra, Inc." without having a valid Fictitious Name Permit.

**Fine**

**WITHIN THIRTY (30) DAYS OF RECEIPT OF THIS CITATION, YOU ARE REQUIRED TO PAY A FINE IN THE AMOUNT OF \$1,500.00 AS PROVIDED IN SECTION 651 OF THE BUSINESS AND PROFESSIONS CODE AND BY TITLE 16 OF THE CALIFORNIA CODE OF REGULATIONS SECTIONS 1364.10-1364.11 FOR VIOLATION OF SECTION 2285 OF THE BUSINESS AND PROFESSIONS CODE AND SECTION 17500 OF THE BUSINESS AND PROFESSIONS CODE.**


