Parent Support & EducationTACA provides education, support and empowerment to more than 38,000 families across the country, with an average of nearly 600 new families joining monthly All of TACA's programs and services are provided at little or no cost to families To ensure access to our programs for all families, TACA provides scholarships for any fee based programs we offer TACA provided parent education, community and support at over 400 chapter meetings and coffee talks in 51 cities across the country We celebrated our 10th year of Real Help Now Conferences, with conferences in Pennsylvania, Wisconsin and California Our parent mentor program completed 641 mentor introductions (increase of 23% over last year) for new families to obtain support and guidance from experienced and trained TACA mentor parents TACA Parent Support team and volunteers handled 33,813 support requests, in English and Spanish, via phone, email and live chat Over 60% of these requests were answered by trained volunteers TACA hosted 20 different autism-friendly events where over 2,000 parents and children gathered TACA held its 7th Annual Leadership Conference where 65 chapter coordinators and key volunteers from 21 states received training on mission delivery, programs, services, and chapter operations Our Spanish community outreach program presented and participated in nearly 10 local conferences in the Latino community This program answered 365 calls and responded to 539 e-mails and provided one-on-one support to 550 parents TACA is able to keep our expenses for parent support & education low because of close to 500 dedicated volunteers that contributed almost 30,100 hours to helping families living with autism

Group, Facebook, and Twitter Our website received almost 1,800,000 page views from users Thirty-nine new articles were added to our website The TACAnow blog had a record 88 posts (including 30 guest posts from our Physician Advisory Board, Chapter Coordinators, and other TACA volunteers Thirty-nine new family stories were placed on the website In 2013, we introduced Webinars to the TACA membership and had over 1,400 families participate in 56 parent centric and 19 mentor specific sessions
