The Weil Foundation Makes Four Inaugural Grants to Advance Integrative Medicine

The Board of Directors of the Weil Foundation announced on October 10 that it had awarded \$60,000 in grants for training and education in integrative medicine. Three grants were made to university programs and teaching hospitals, the fourth to a national botanical organization. These are the first grants made by the Weil Foundation.

"We are pleased to be able to provide this support to four outstanding organizations," said Andrew T. Weil, M.D., chairman of the Foundation board. "Their pioneering work will help to create a health care system that fully recognizes the natural healing capacity of human beings, emphasizes prevention above treatment, ensures appropriate use of both conventional and alternative therapies, and makes doctors and patients true working partners."

The Program in Integrative Medicine at the University of Arizona, Tucson, received \$30,000 to develop an on-line educational module for physicians and pharmacists in botanical medicine and women's health. A pioneer in using on-line assets for distance learning for health professionals in integrative medicine, the Program intends this module to provide physicians and pharmacists with a sound basis in science for advising patients about the safety, efficacy, and uses of botanical preparations for conditions commonly presented by women. www.integrativemedicine.arizona.edu

The Maine Medical Center Family Practice Residency Program (Portland, Maine) received \$15,000 to continue the pilot implementation of its combined family medicine residency and integrative medicine fellowship. www.mmc.org
