

**ORDER OF FINE; GRANTING SIX MONTHS
TO COMPLY WITH 201 KAR 9:310**

Based upon a review of the records of the Kentucky Board of Medical Licensure (hereafter "the Board"), the Board FINDS that the licensee has failed to 1) timely complete the continuing medical education requirements of 201 KAR 9:310; and, 2) obtain an extension of time for completion of the continuing medical education requirements. Accordingly, the Board ORDERS that a FINE of FOUR HUNDRED DOLLARS (\$400.00) is imposed against the licensee, with the fine being due and payable immediately.

Pursuant to 201 KAR 9:310, Section 7(2)(a), the licensee is GRANTED a period of six (6) months, until May 12, 2004, to come into compliance, by paying the fine imposed and by completing the continuing medical education requirements. NOTICE is hereby given that, if the licensee should fail to come into compliance within that six (6) month period, the license to practice medicine in the Commonwealth of Kentucky held by the licensee shall be immediately suspended and shall remain suspended until the licensee has submitted verifiable evidence that the licensee has completed the continuing medical education requirements.

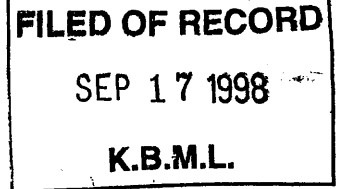



ORDER TERMINATING AGREED ORDER

The Kentucky Board of Medical Licensure, acting by and through its Inquiry Panel B, considered a request by the licensee to terminate the Agreed Order entered into by the parties on September 3, 1991. Panel B reviewed a memorandum by the Board's General Counsel; the Agreed Order filed September 3, 1991; an October 8, 1997 letter by the General Counsel to Phillip G. Abshier, Esq.; letters dated May 5, 1998 and September 30, 1997 by Mr. Abshier; and, a Response to Memorandum filed by General Counsel filed by Mr. Abshier, with attachments. The Panel also heard oral comments from the General Counsel and Mr. Abshier. Based upon its review of these materials and based expressly upon the licensee's written assurance that he will continue to practice in accordance with the terms of the Agreed Order, Panel B hereby ORDERS that the Agreed Order filed September 3, 1991 is TERMINATED, effective upon the filing of this Order.

AGREED ORDER

Comes now the Kentucky Board of Medical Licensure ("Board"), by and through its Inquiry Panel B, and John C. Tapp, M.D., both parties represented by counsel, and enter into the following Agreed Order, effective this date, subject to the following terms and conditions:

1. Dr. Tapp shall immediately cease and desist from utilizing the following treatment modalities:
 - a) EDTA/Chelation therapy for arteriosclerotic cardiovascular disease;
 - b) Intravenous colchicine for chronic pain;
 - c) Balanced hormone injections for control of pain associated with arthritic conditions;
 - d) Intravenous vitamin therapy for treatment of fatigue;
 - e) Intravenous hydrogen peroxide; and
 - f) Intravenous bronchodilator (Vitamin C, peridoxine, magnesium chloride, panthothenic acid, niacin, calcium glycerophosphate and adrenal cortical extract).


Said agreement to cease and desist from utilizing the above-referenced treatment modalities shall not preclude Dr. Tapp from utilizing said treatment modalities should such be recognized as acceptable by prevailing medical practice standards within the Commonwealth of Kentucky, or should said treatment modalities be approved by the Board.


By consenting to terms contained in this Agreed Order, Dr. Tapp does not admit any wrongdoing, but simply agrees with the

Board to discontinue rendering treatment as hereinabove described. Should he violate any of the above-referenced terms and conditions of this Agreed Order, the Board or its appropriate panel may issue and serve a complaint on Dr. Tapp pursuant to KRS 311.591.


